Dear Parent / Carer,

I write with a number of updates and requests:

**Young Carers**

We believe that no barriers should exist between our pupils and their education. We are keen to understanding the needs of young carers and how to support them to achieve their full potential. A young carer is a person under 25 who helps take care of a family member with an illness, disability, and/or addiction. Young carers carry out various daily tasks to support this person. These could include but are not limited to:

- Practical tasks – such as cooking, housework, shopping
- Physical care – such as lifting, helping up the stairs, physiotherapy
- Personal care – such as dressing, washing, helping someone go to the toilet
- Emotional support – such as listening, calming someone, being there for someone
- Household management – such as paying the bills, managing finances, collecting benefits
- Looking after siblings – such as putting to bed and walking to school
- Interpreting for parents – with hearing or speech impediments or language barriers
- Administering medication – such as insulin needles and preparing tablets

We are already aware of a number of young people within our school who are identified young carers but would encourage all families that this may apply to, to please contact school to talk through possible support both in school and externally. ### **Year 11 Revision**

In order to further support Year 11 pupils in their independent revision at home we provided your child with a full set of revision guides a few weeks ago. Each pupil was given a total of 8 books for them to use at home for the revision period, each guide is the pupils' own responsibility. These books are not expected to be paid for as the school has purchased them (at quite a financial cost), but we do expect your child to look after them. All revision guides will be expected to be returned on a "clearance day" after the exams- we will let them know this date in due course. We do hope that providing a revision guide for each subject will not only help you in the financial cost of supporting your child during the exam period but also help support mock and GCSE exam success by enabling students to have the correct resources to revise at home.
